

# On Deck Skateboard Shop - Skateboard Waiver

1. I understand that skateboarding is a hazardous and dangerous activity that requires strenuous exercise and various degrees of skill and experience for the different skateboard terrain conditions. I understand that these activities can result in serious injury to the person and damage to property and even death. I am aware of the risks, hazards and dangers of personal injury, death and or disability inherent in participating in any skateboard event, and I VOLUNTARILY ASSUME SUCH RISKS.
2. I hereby assume all the risks described above, even if On Deck Skateboard Shop's and/or its independent contractors, employees or agents, through negligence or otherwise, are deemed to be liable. I hereby agree not to sue and release, waive, and discharge On Deck Skateboard Shop, its independent contractors, employees, agents, coaches, and/or other participants, from any and all liability arising out of my participation in skate lessons, or during any public skate, even if such liability arises out of negligence that may or may not be foreseeable at this time.
3. I understand that I MUST WEAR A HELMET AT ALL TIMES while skateboarding at On Deck Skateboard Shop.
4. I understand, consent to authorize, in advance, the use of my name, voice, picture or other likeness, in combination or alone, in any broadcast, telecast, print medium, advertising, promotion or other account by On Deck Skateboard Shop.
5. I represent that my minor child is in sufficiently good physical condition to participate in paid skateboarding sessions and/or programs without jeopardizing his/her health. I understand that I and my child (ren), have given up substantial rights by signing this waiver and release and sign it voluntarily and without any duress. This wavier and release will be effective and binding upon my heirs, agents, personal representatives and assigns.
6. I give my consent and permission to On Deck Skateboard Shop, to obtain, on behalf of myself or my minor child (ren), any emergency medical attention that may be required, at my expense, and I agree to indemnify and save you completely harmless in respect to such expenses.
7. The undersigned, and I if I am a minor, my parent or legal guardian, in consideration of being allowed to participate in On Deck Skateboard Shop Skateboard Sessions, Skateboard Lessons, and all related events and activities have executed this waiver and release.
8. \*THIS FORM MUST BE SIGNED IN PERSON BY PARENT (S) OR LEGAL GUARDIAN (S) OF ALL PARTICIPANTS UNDER THE AGE OF 18 AND WITNESSED BY AN ON DECK SKATEBOARD SHOP EMPLOYEE. INCASE OF INJURY, ALL POSSIBLE ATTEMPTS WILL BE MADE TO NOTIFY THE PARENT OR GUARDIAN OF MINORS.
